EXAMPLES OF WORK:

Positions in this class treat, remove, transport and dispose, through agricultural land application, of municipal waste water plant residuals under strict environmental regulation. Operates belt press, sludge de-watering equipment at a municipal waste water treatment plant, loads and transports properly dehydrated sludge; treats using lime stabilization process, operates dump trucks, applies sludge to agricultural land using spreading, spraying, chopping equipment according to established procedures. Under established guidelines, takes samples, measures acidity, adds lime as necessary. Makes minor repairs and adjustments to belt presses, pumps, wash down and sanitation equipment. Performs related work as required.

MINIMUM QUALIFICATIONS:

- Completion of High School or equivalent required.
- Substantial experience as necessary to become proficient in operating a variety of plant and automotive equipment used in sludge treatment, transport, and land application is desired.
- At least a valid drivers license required to test and must obtain a valid Louisiana commercial driver's license Class B with air brake endorsement within 45 days of appointment. Must meet the general requirements of the City's auto insurance company.
- State of Louisiana Department of Health and Hospitals Wastewater Treatment Certification Class I is desired, as is a working knowledge of New Iberia's Land Application Permit requirements.
- -Must pass the Civil Service Exam, the post-offer drug screen, physical, and functional pre-placement testing.
- -Must be a registered voter; a copy of the voter of registration card must accompany the application.

Essential Functions: Mobility, lifting up to 52 pounds, climbing, manual dexterity and strength sufficient to operate and maintain plant and automotive equipment are essential, as are vision of at least 20/40 in each eye and depth perception of 80 seconds of arc or better; hearing, speech, and agility within normal limits.
